#### 1.0 INTRODUCTION

This report highlights the Girls Advocacy Alliance (GAA) programme activities carried out by Rights and Responsibilities Initiatives Ghana (RRIG) in the Bekwai Municipality in the Ashanti Region for the period January – December, 2018. The GAA programme focuses on the following 4 thematic areas:

- Ending Child Marriage
- Ending Sexual Violence and Abuse
- Ending Commercial Sexual Exploitation of Children
- Promoting access to Technical Vocational and Educational Training and decent employment opportunities for Girls and Young Women

#### **2.0 THEME**

The theme for the Girls Advocacy Alliance programme is Advocating for Girls' Right: Equal Rights and Opportunities for Girls and Young Women in Ghana.

### **3.0 PROJECT AREA**

The project is implemented in ten (10) selected communities in the Bekwai Municipality in the Ashanti Region of Ghana. Below is the list of the project communities:

### 4.0 IMPLEMENTED ACTIVITIES FROM JANUARY - DECEMBER, 2018

### 4.1 Training of School Based Facilitators in all the 10 GAA Project Schools

A – day training was organized by Rights and Responsibilities Initiatives Ghana (RRIG) for School Based Facilitators in the 10 Girls Advocacy Alliance project schools in the Bekwai Municipality. The purpose of the training was to build the capacity of School Based Facilitators in the project school to adequate approach and resolve child protection issues reported to them. A total of 14 participants were present, where 2 were male and 12 were female. Among participants were School Based Facilitators from Pepedan SDA JHS, Kwamang M/A JHS, Bogyawe M/A JHS, Ankase M/A JHS, Sanfo Aduam M/A JHS, Asokwa SDA JHS, Anglican JHS, Asanso M/A JHS and Denyase M/A JHS, Girl Child Coordinator for Bekwai Ghana Education Service, Deputy Coordinating Director and staff of RRIG.



### 4.2 Follow up on Community Child Protection Committee in the 10 project communities

5 follow up was undertaken on Community Child Protection Committees in all the 10 GAA project communities to access the status of 4 thematic areas of the GAA program in the communities in the Bekwai Municipality in the Ashanti Region. The discussions were centered on:

- The negative effects of Gender Based Violence (GBV) on children
- The link between GBV and HIV and AIDS
- Drafting of bye-laws to protect children in the project communities
- Identified child protection issues for the necessary referrals

### 4.3 International Women's Day Celebration at Boyawe M/A JHS on the theme "Press for Progress"

RRIG celebrated the International Women's Day with the Bogyawe M/A JHS on the theme "Press for Progress". The purpose of the celebration was to empower girls to promote gender inclusiveness in the community and the Bekwai Municipality as a whole. A total of 119 participants were present where 56 were female and 63 were male. Among the participants were pupils and teachers of Bogyawe M/A JHS, Community Child Protection Committee, the National Youth Advocate for Ashanti Region and staff of RRIG. Dora Oteng, a Youth Advocate in the Bogyawe M/A JHA made strong emphasis that girl child education is very important in nation building and the best strategy to end Child Marriage.

### **4.4 Community Child Protection Committee Review Meetings**

3 Review Meetings were organized by Rights and Responsibilities Initiatives Ghana (RRIG) for Community Child Protection Committees (CCPC) in the 10 GAA project communities in the Bekwai Municipality to access the status of the 4 thematic areas of the GAA project in the project communities as well as to share experiences among CCPC. The meeting comprises of 2 representatives from each of the 10 project communities. Please find below the total participants reached during the period under review.

# 4.6 Monitoring visit to Bekwai Municipality by Ghana NGOs Coalition on the Rights of the Child (GNCRC), Plan International Ghana and Defence for Children International (DCI) – ECPAT Netherlands

A day monitoring visit was undertaken in the Bekwai Municipality by the donors of the GAA programme. The monitoring team includes: GNCRC, Plan International Ghana, DCI-ECPAT Netherlands and staff of RRIG. The purpose of the visit was to monitor the progress of the project since its inception in the Bekwai Municipality. Among the visited key actors was:

- Gender Office
- Deputy Coordinating Director
- Assembly Member for Bekwai Zongo
- Community Child Protection Committee in Ankaase, Asokwa, Denyase and Nyameduase

# 4.7 International Children's Day celebration at SDA JHS on the theme "Leaving no child behind in ending violence against the child"

International Children's Day was celebrated at SDA JHS in the Askowa Community in the Bekwai Municipality in the Ashanti Region. The day was celebrated to educate children about their rights in accordance to the Declaration on the Rights of the Child and Convention on the Rights and the Child. It was also dedicated to a theme of bringing awareness to children who have succumbed to violence in forms of exploitation, abuse and discrimination. The theme adopted by Rights and Responsibilities Initiatives Ghana for the celebration was "Leaving no child behind in ending violence against the child". A total of 187 participants were present where 101 were female and 86 were male. Participants included students and teachers of SDA JHS, Asokwa Community Child Protection Committee (CCPC) members and staff of RRIG.

### 4.8 Community Radio Discussion on Child Rights at Ankaase and Kwamang Communities

RRIG organized a Community Radio discussion at Ankaase and Kwamang and their surrounding communities on Child Rights with reference to the Declaration on the Rights of the Child and the Convention on the Rights of the Child. Table 1 depicts the total of number of people reached:

### 4.9 PTA Meetings at Ankaase M/A JHS

RRIG was invited to attend two (2) PTA meetings at the Ankaase M/A JHS. The meeting stressed on the parent-teacher, child-teacher and child-parent relationships as a strategy to improve academic performance on children in schools. Both teachers and parents were enlightened about their role in protecting children from violence, abuse, exploitation, cruelty and neglect.

# 4.10 World Day against Child Labour celebration at Kwamang M/A JHS on the theme "Generation safe and health"

Rights and Responsibilities Initiatives Ghana (RRIG) celebrated the 2018 World Day against Child Labour in Kwamang M/A JHS premises. The theme for the celebration was generation safe and health. The rationale for the celebration was to raise the awareness on the negative of child labour on the education and health of children. A total of 62 participants were present, 32 were female and 30 male. Among the participants were students and teachers of Kwamang M/A JHS and staff of RRIG.

# 4.11 International Day of the African Child Celebration at Ankaase M/A JHS on the theme "Leave No Child Behind for Africa's Development"

RRIG celebrated the 2018 International Day of the African Child at Ankase M/A JHS in the Bekwai Municipality of the Ashanti Region. The theme for the celebration was "Leave No Child Behind for Africa's Development. The celebration focused on the need to mainstream children's rights in all the Agenda 2030 developmental program implemented by member states. It also highlighted the need to ensure that "no child is left behind" by specifically targeting those who are not benefiting from Africa's growth and development. A total of 56 participated in the program where 23 were female and 33 were male. Among the participants were students and teachers of Ankase M/A JHS, Bekwai Girl Child Coordinator and staff of RRIG.

### 4.12 Monitoring visit to School Based Facilitators (SBF) in all the 10 GAA project schools

Rights and Responsibilities Initiatives Ghana (RRIG) undertook a monitoring visit to the School Based Facilitators (SBF) in all the 10 Girls Advocacy Alliance (GAA) Project Schools in the Bekwai Municipality. The purpose of the visit was to monitor the action plans and programs of the SBF in relation to 4 thematic areas of the GAA project: ending Child Marriage, Sexual Violence and Abuse, Commercial Sexual Exploitation among Children (CSEC) and improve access to TVET and decent employment opportunities for Girls and Young Women in the Bekwai Municipality. # 4.13 Training for Champions of Change

A day training was organized by Rights and Responsibilities Initiatives Ghana (RRIG) for Champions of Change from all the 10 GAA project communities in the Bekwai Municipality in the Ashanti Region. The training aimed at empowering champions to speak out against Gender Based Violence in ending Child Marriage, Sexual Violence and Abuse, Commercial Sexual Exploitation among Children and Child Labour in the municipality. A total of 24 participants were present, where 13 were male and 11 were female. Participants comprised of Community Child Protection Committee in all the 10 project communities, Girl Child Coordinator for Bekwai Ghana Education Service, Department of Social Welfare, Youth Advocate and staff of RRIG.

### **4.14 Segmented Focus Group Meetings**

Rights and Responsibilities Initiatives Ghana undertook 10 segmented group meeting in 9 Girls Advocacy Alliance (GAA) project communities using the child protection flash cards to discuss child protection issues that affect child welfare and development. The purpose of the meetings is to initiate processes to protect children from violence, abuse, exploitation and neglect in ending Child Marriage, Sexual Violence and Abuse, Commercial Sexual Exploitation among Children (CSEC) and access to TVET and decent employment opportunities for Girls and Young Women in the Bekwai Municipality. A total of 324 participated in the meetings where 80 are male and 244 female. Among the participants were Youth Group, Parents and Guardians, Women Group, Men Group and Community Leaders. The table below depicts the participants who attended the meeting.

# 4.15 International Youth Day celebration at Bekwai Zongo Community on the theme "Time and Space greatest currency for Youth Development"

Rights and Responsibilities Initiatives Ghana visited the youth in the Bewkai Zongo Community to join them in celebrating the International Youth Day on August 12, 2018 on the theme "time and space greatest currency for Youth Development. The celebration focused on creating safe spaces for youth to take initiatives of their own welfare and development. A total of 73 people were reached where 37 were female and 36 were male. ### 4.17 2018 National Girls Camp on the GAA programme

The 3 GAA Alliance team (Ghana NGOs Coalition on the Rights of the Child, Plan International Ghana and Defence for Children International Ghana) organized a one – week camp meeting at the GNAT Hostel Nungua, Accra dated 19<sup>th</sup>-25<sup>th</sup> August, 2018 for some selected girls from the Rights of the Child Clubs in the GAA project schools in the Ashanti, Upper West, Northern and Eastern Regions of Ghana. The camp meeting was to create a platform for girls to share their experiences and to acquire skills and knowledge to protect themselves from abuses, violence, exploitation and other forms of harm. A total 11 participants were selected from RRIG project district (the Bekwai Municipality) to participate in the camp meeting of which 9 were members of the Rights of the Child Club, the Girl Child Coordinator for Bekwai Ghana Education Service and the Programme Manager for RRIG.

### 4.18 Mid-Year Review Meeting of the GAA programme in the Bekwai Municipality

A two-day mid-year review was conducted in the Bekwai Municipality to access the impact of the project on beneficiaries. The review was conducted by 2 staff from the Kanko Associates, a consultant hired by the 3 Alliance Team. The following groups were visited during the period under review:

# 4.19 International Day of the Girl Child celebration at the Hussainiya Islamic School on the theme "With Her: A Skilled Girlforce"

On Saturday, October 13, 2018 Rights and Responsibilities Initiatives Ghana (RRIG) joined the adolescent girls of the Hussainiya Islamic School in the Bekwai Zongo Community in the Bekwai Municipality of Ashanti Region to celebrate the International Day of the Girl Child (IDG) on the theme "With Her: A Skilled GirlForce". The purpose of the celebration was to interact with the adolescent girls on their educational and career aspiration for the future and to highlight and address the needs and challenges girls face, while promoting girls' empowerment and the fulfillment of their human rights. A total of 35 participants were present of which 33 were female and 2 were male. The table below depicts the participants that were present for the program

# 4.20 Training for Rights of the Child Clubs in all the 10 GAA project schools in the Bekwai Municipality

RRIG organized a training session for the 10 Rights of the Child Club in the Bekwai Municipality. The purpose of the training was to empower girls to be assertive and to protect themselves from violence, abuse and all forms of exploitation using the community sensitization toolkits. The topic for the training was "Boys and Girls Role Analysis and its impact on the wellbeing of the girl child". A total of 297 people participated in the training of which 271 were female and 26 were male. The table below shows the total participants who were present during the training sessions:

# 4.21 16 days of activism against Gender-Based Violence (GBV) in the 10 GAA project communities in the Bekwai Municipality

RRIG embarked on community sensitizations in all the 10 project communities to mark the 16 days of activism against Gender Based Violence including School-related Gender Based Violence in the Bekwai Municipality. The purpose of the campaign was to raise the awareness of children, parents/ guardians, community leaders, religious and traditional leaders about the negative consequences of Sexual and Gender Based Violence on the child, family, Community and the nation as a whole. A total of 1,374 participants were reached where 903 were female and 471 were male. The table below shows the participants who were reached during the period under review.

#### **5.0 KEY MESSAGES**

- 1. Every child has the right to life, education, health and the benefits of scientific progress.
- 2. There should be a zero tolerance for school drop-out and absenteeism.
- 3. Teenage mothers should be encouraged to return to school
- 4. The best strategy of ending Child Marriage, Sexual Violence and Abuse, Commercial Sexual Exploitation of Children and Child labour is to keep girls in school longer to achieve their economic independence through Technical Vocational and Educational Training (TVET) programmes.

#### **6.0 DONATION**

A total of 520 pieces of exercise books were donated to five (5) Rights of the Child Club (ROCC) in 5 GAA project schools in the Bekwai Municipality. Among the 520 pieces of exercise books donated, 100 pieces of exercise books was donated to each of the following schools: Bogyawe M/A JHS, Bekwai SDA JHS, Kwamang M/A JHS, Hussainya Islamic School and Ankaase M/A during the 2018 International Women's Day, International Children's Day, World Day against Child Labour, International Day of the Girl Child and International Day of the African Child. The remaining 20 pieces of exercise books including school bag and pens were donated to support 2 students: Ankaase M/A JHS and Denyase M/A Primary School



during their re-entry to the mentioned school after dropping out of school for 1 year. This donation was done through the Community Child Protection Committees in Ankaase and Denyase.

### **8.0 SUCCESS STORIES**

- a. 3 girls have been rescued from Child Marriage in the Bogyawe and Denyase communities through the support of the Community Child Protection Committees in the mentioned communities.
- b. 5 teenage mothers in the Asanso Community in the Bekwai Municipality in the Asanti Region have returned to school after constant engagement with Community Child Protection Committee in the Community.
- c. Community members are slowly changing and responding to the project objectives of advocating against Child Marriage, Sexual Violence and Abuse and Commercial Sexual exploitation among Children and keeping girls in school longer to achieve economic independence through Technical Vocational Educational Training for Girls and Young Women.
- d. 20 Champions of change have been identified among the project communities in the Bekwai Municipality and trained on the concept of child protection in relation to the 4 thematic areas on the GAA project. The champions have set up task forces to monitor and eliminate Child Marriage, Commercial Sexual Exploitation among Children, Child Neglect, Child Labour and Sexual Violence and Abuse in their communities and beyond.
- e. The community leaders are generally focused on pursuing bye-laws to end Child Marriage. The Community Child Protection Committee in the Ankase Community in the Bekwai Municipality in the Ashanti Region has drafted a bye-law which has been submitted to the Bekwai Municipal Assembly for ratification. The remaining communities have started dialoguing with community leaders to draft their bye-laws.
- f. There is youth participation in review meetings organized by Rights and Responsibilities Initiatives Ghana.



- g. The exceptional support provided by the Queen Mother of Bekwai to the project is encouraging women groups and leaders to take active participation in the project activities in their communities.
- h. School Based Facilitators in the project schools are becoming more assertive and conscious on child protection related issues.
- i. More communities are sending child abuse such as parental neglect, child labour, commercial sexual exploitation of girls, non-maintenance of children related issues to Duty Bearers of child protection such as the Department of Social welfare, Commission of Human rights and Administrative Justice and the Domestic Violence and Victims Support Unit of the Ghana Police Service.
- j. Community members now are promoting the rights of Children with Disability to attend school. In one community where a head teacher refused to admit an autistic child into his school the guardians contacted RRIG to lead them to lodge a complaint at the Municipal Education office. The child has since been admitted into another school, when the previous headmaster provided evidence that the school was full.
- k. Twenty (20) Champions of change are articulating the ideals of the Girls Advocacy Alliance Project beyond the project communities.
- I. The project has encouraged intergenerational discussions about girls' empowerment between the young girls and older people in their respective communities. This has deepened the respect the girls have for the guidance the older people are giving them to achieve their education, economic and social potential.
- m. The Bogyawe M/A JHS in the Bekwai Municipality recorded zero teenage pregnancy after the Basic Education Certificate Examination (BECE) in April, 2018
- n. The Ankaase Community Child Protection Committee has liase the Ghana Police Service to eradict drug abuse among children and youth in the community. Two boys have been arrested and kept in the police custody.
- o. Youth Advocates have started organizing focus group discussion among their peers focusing on the concept of child protection and life skills. Examples of such advocates include Morrisca Serwaa Gyamfi of Kwamang M/A JHS, Perpetual Asare of Sanfo Aduam M/A JHS, Mabel Asantewaa Ennin of Anglican JHS and Sandra Yeboah of Pepedan SDA JHS in the Bekwai Municipality in the Ashanti Region.
- p. The Youth Advocate in the Ankaase M/A JHS has taken the lead role to advocate on ending Child Marriage, Teenage Pregancy and Commercial Sexual Exploitation among girls in the school and community.

### 9.0 CHALLENGES

- a. Some Community Child Protection Committee member's constant demand for incentives.
- b. During the last quarter, most of the project activities were postponed because the scheduled dates were clashing with the local community activities in some communities as well as sporting activities in some project schools in the Bekwai Municipality in the Ashanti Region.
